The attractive apartments include some recently refurbished apartments in the Georgian wing of Middleton Hall. All feature a living room, bedroom and an accessible bathroom. The kitchens are equipped so that residents have the choice of preparing their own meals, promoting independence.

All residents benefit from the support of our Health and Wellbeing team, with access to the swimming pool, fitness areas, activities, events, and weekly outings. Following a personal assessment, we create tailored support plans to meet any additional care or other needs.

Apartments include a telephone, smart TV, Wi-Fi, and some furnishings, with the option to bring your own.

Dining is flexible with a range of different options available. Whilst some residents choose to cook in their apartment, others opt to have all their meals provided. We encourage residents to share lunch in the dining area, as we know a positive dining experience is an important part of daily life.

Transport assistance is available for health and wellbeing appointments, with an escort provided by our care team if required.

FEES AND APARTMENT OPTIONS

Our ongoing refurbishment programme will introduce five distinct styles of modern, thoughtfully designed accommodation across sixteen spacious apartments. Several of our larger apartments are suitable for shared living, offering flexibility for couples.

Weekly fees begin at £1,592 for single occupancy and £2,328 for couples sharing, based on the independent package. Rates vary depending on the apartment's style and size, as well as the level of care and support required.

Short stay breaks are subject to availability and can be used for holiday, post operative recuperation or to allow family time to have a break from a caring role as well as an opportunity to experience life at Middleton Hall if considering longer term residential care.
